Purchase Agreement/Health Guarantee

First and foremost, thank you for deciding to purchase one of our puppies. We strive to breed excellent working and family Aussies. We would like to provide a stress free and enjoyable buying experience. If you have any questions or concerns please feel free to contact us about anything. As your puppy grows and develops we will keep you up to date with pictures, videos and all information in regards to your puppy.

This contract is written for the protection of both the buyer and the breeder. However, it is primarily written to protect the health and general well being of the puppy.

Purchase Agreement

1. Please read the health guarantee completely before putting a deposit on a puppy. By putting a deposit on a puppy you are agreeing to the terms and conditions within this contract.
2. We require a \$250 deposit in order to hold the puppy of your choice. The deposit can be in the form of cash, or venmo.
3. This deposit is NON-REFUNDABLE, unless there is a problem with the health of your puppy. In that case the buyer will have the option of a full refund or transferring the deposit towards a different puppy.
4. Puppies require a lot of work and time, please be sure that you are ready for the time and financial commitment of a puppy prior to putting a deposit down.

Health Guarantee

1. The puppy stays with us, the breeder, until it has reached 8 weeks of age. We will not, under any circumstance let the puppy leave prior to it being ready to go.
2. The puppy is guaranteed to be in good health at the time of sale.
3. The puppy will be up to date on shots and deworming at the time of pick up. These records can be found in your folder within your puppy bag. It is very important that you the owner continue the vaccinations and deworming to ensure a healthy puppy. Please do not expose your puppy to other dogs that are not vaccinated until he/she has completed the entire vaccination schedule. (No dog parks etc.) By exposing your not fully vaccinated puppy to other un-vaccinated dogs you are increasing the chance the puppy could end up sick.

4. The puppy will have had tails docked and deemed in good health at the time of sale. We work very closely with veterinarians and vet techs to ensure our vaccinating programs and deworming programs are up to par.
5. The buyer, at their own expense, should have the puppy examined by a Licensed Veterinarian within four days of receiving the puppy. Failure to do so will null and void the Health Guarantee.
6. If within four days a licensed vet finds the puppy to be unhealthy or unfit for sale, the puppy may be returned for a full refund – providing the puppy has not been injured or neglected. The veterinarian must provide a written statement deeming the puppy “unhealthy for purchase”.
7. The guarantee does not cover any health issues caused by neglect or injury from the buyer.
8. The breeder can not assume responsibility for this puppy after four days of the sale. It is the responsibility of the buyer to care for the puppy properly and keep it free from harm. Please remember that your puppy must be treated with great care and protected from danger.
9. The breeder assumes no responsibility for any medical expenses incurred after the sale.
10. The breeder assumes no responsibility for training difficulties or behavior problems.
11. The breeder does not guarantee size. We will give the buyer the weight of the puppy’s parents and the weight of other puppies out of that mating. We can give the buyer an educated guess as to full grown weight, but there are too many variables besides genetics.
12. The breeder does not guarantee fertility or ability to place in shows.
13. If for any reason I am unable to keep the puppy, I agree to return the puppy to Rockin D Ranch and not place the puppy in another home unless given permission by the breeder. If the puppy is returned within 2 weeks of initial purchase, only half the purchase price of the puppy will be refunded after the puppy has been placed in his/her new home. The other half will cover the cost of re-advertising and keeping the puppy current on vaccinations and deworming until the puppy is placed in his/her new home. If the puppy is returned after the 2 weeks no money will be refunded.
